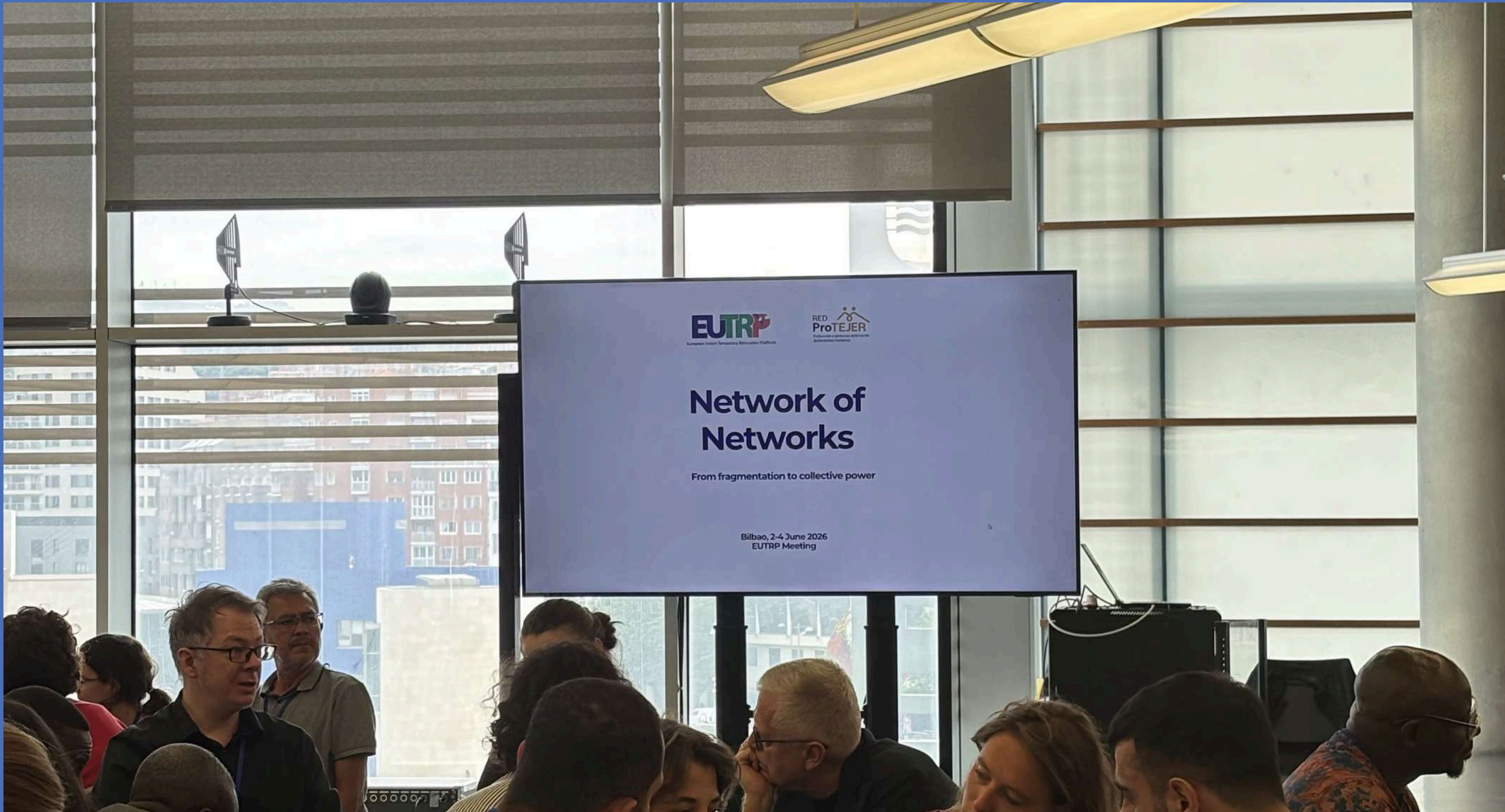


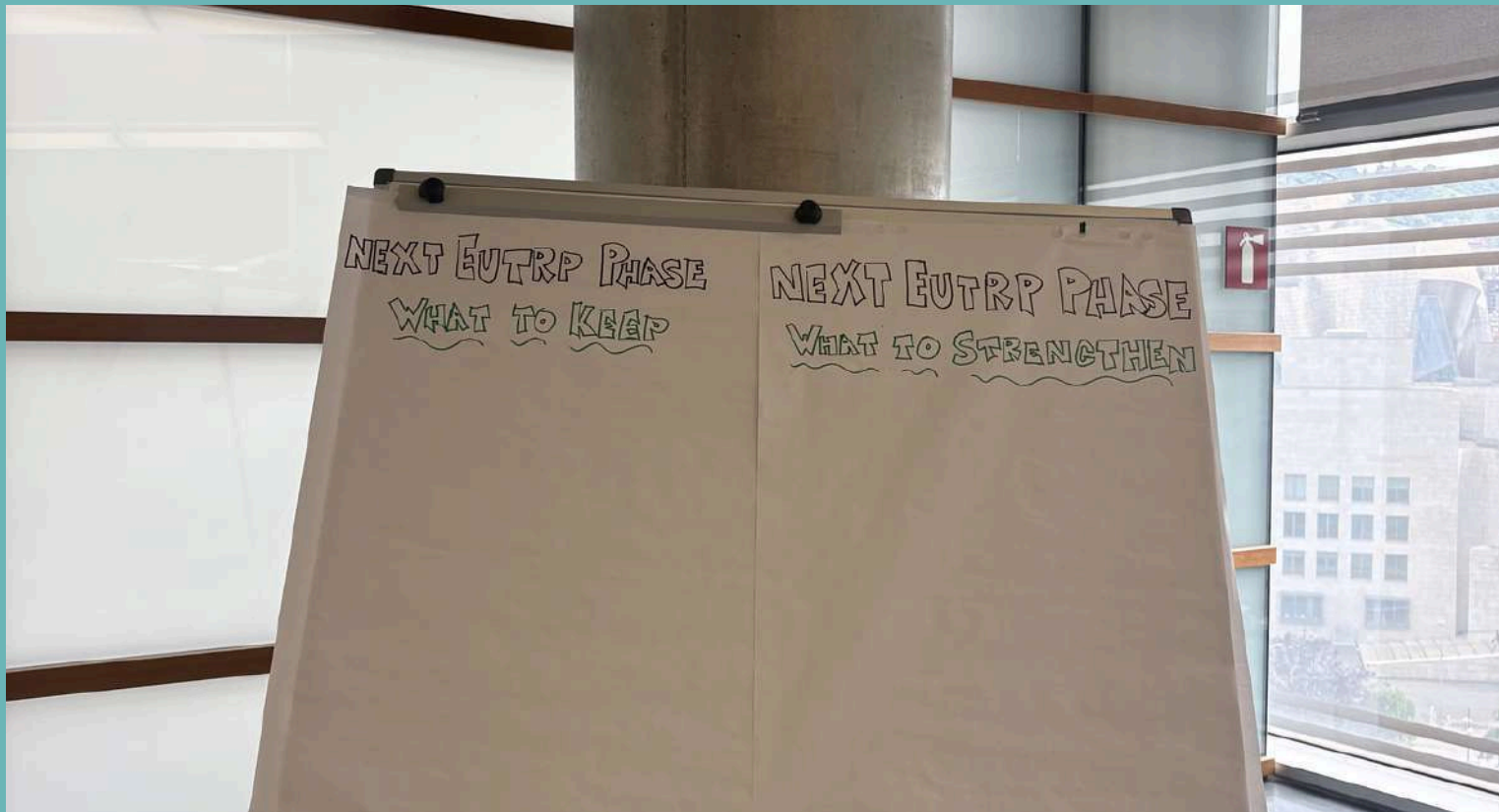

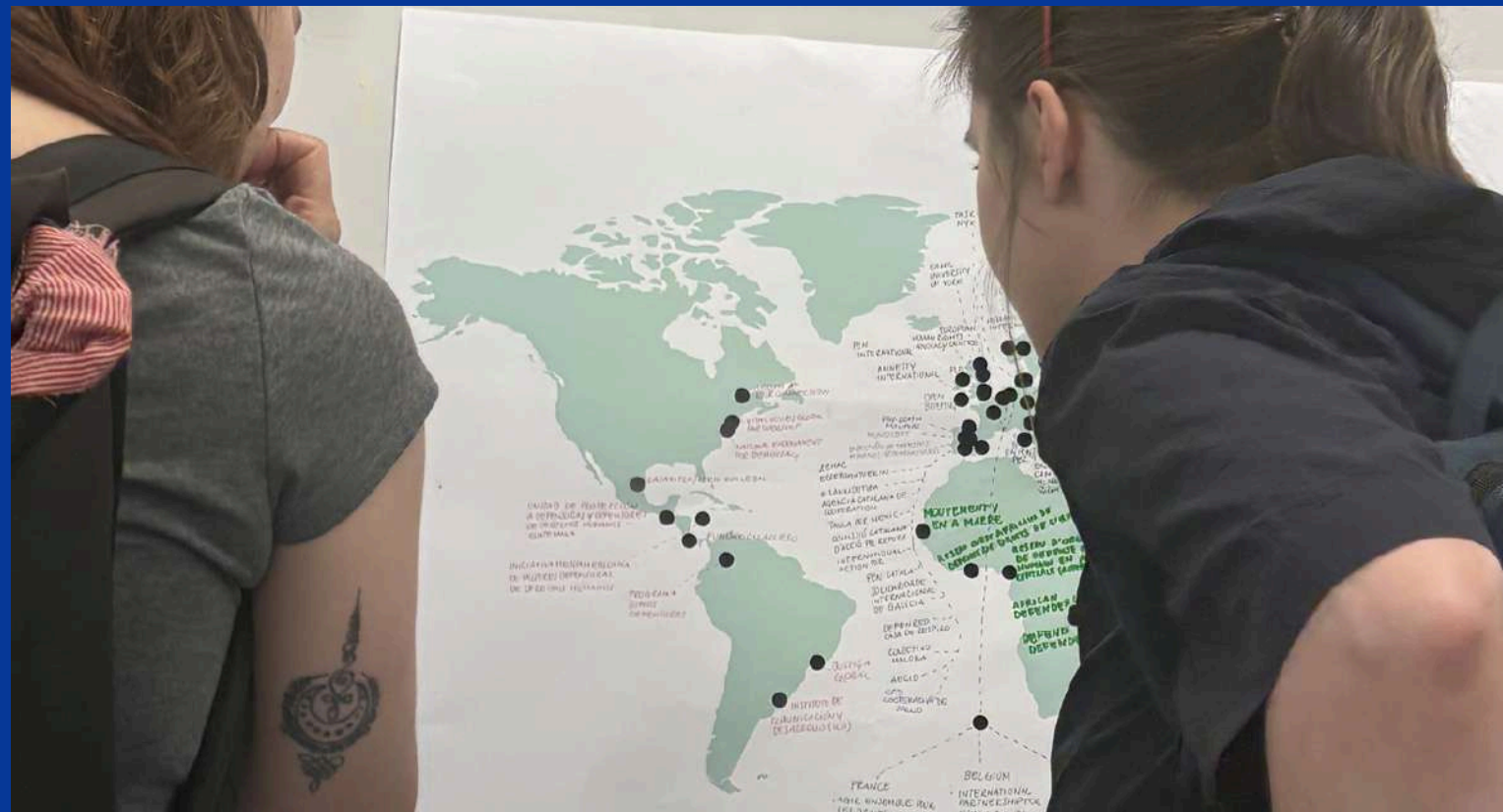

 Mapping of members, mandates, expertise, resources & referral pathways.
 - * LAUNCH REGIONAL & THEMATIC COMMUNITIES OF PRACTICE
 Regular exchanges, peer-learning and member-led EUTRP Talks.
 - * ESTABLISH A PSYCHO-SOCIAL NETWORK
 Share tools, expertise, resources and referral options across the EUTRP
 - * STRENGTHEN CRISIS PREPAREDNESS & COLLECTIVE RESPONSE
 Information sharing, CRISIS RESPONSE DIRECTORIES.
